2. It is also noted that “M/s The Tinplate Company of India Limited” has submitted no objection certificate that “M/s Tata Steel Limited, Tinplate Division” shall abide all the conditions prescribed in the Environmental Clearance letter no. EC/SEIAA/2020-21/2480/2021/367, date : 30.01.2023 issued in the favour of “M/s The Tinplate Company of India Limited” and have also agreed for the transfer on the same terms and conditions under which prior Environmental Clearance was granted.

3. The Scheme of Amalgamation of The Tinsplate Company of India Limited (CIN: L28112WB1920PLC003606) into and with Tata Steel Limited (CIN: L27100MH1907PLC000260) ('Scheme of Amalgamation'), as approved and sanctioned by the Hon'ble National Company Law Tribunal (Hon'ble NCLT), Mumbai Bench (having jurisdiction over Tata Steel) vide its order dated 20th October, 2023 and the Hon'ble NCLT, Kolkata Bench (having jurisdiction over the Company) vide its order dated 01st January, 2024.

4. The proposal was considered by the State Level Environment Impact Assessment Authority, Jharkhand in its 114th meeting held on 09th & 10th July, 2024 and the Authority has approved the proposal for transfer of Environmental Clearance in the name of "M/s Tata Steel Limited, Tinsplate Division".

5. The Authority has no objection for transfer of Environmental Clearance accorded by the SEIAA, Jharkhand letter no. : EC/SEIAA/2020-21/2480/2021/367, date : 30.01.2023 in the name of "M/s Tata Steel Limited, Tinsplate Division" from "M/s The Tinsplate Company of India Limited" with the same terms and conditions under which prior Environmental Clearance was granted for the same validity period subject to satisfactory compliance of all the stipulated specific and other conditions. You are also requested to obtain consent to Establish and Consent to operate from the State Pollution Control Board in the name of "M/s Tata Steel Limited, Tinsplate Division".

6. In case any change is proposed in the scope of the project, the project Authority shall obtain fresh prior Environmental Clearance.
