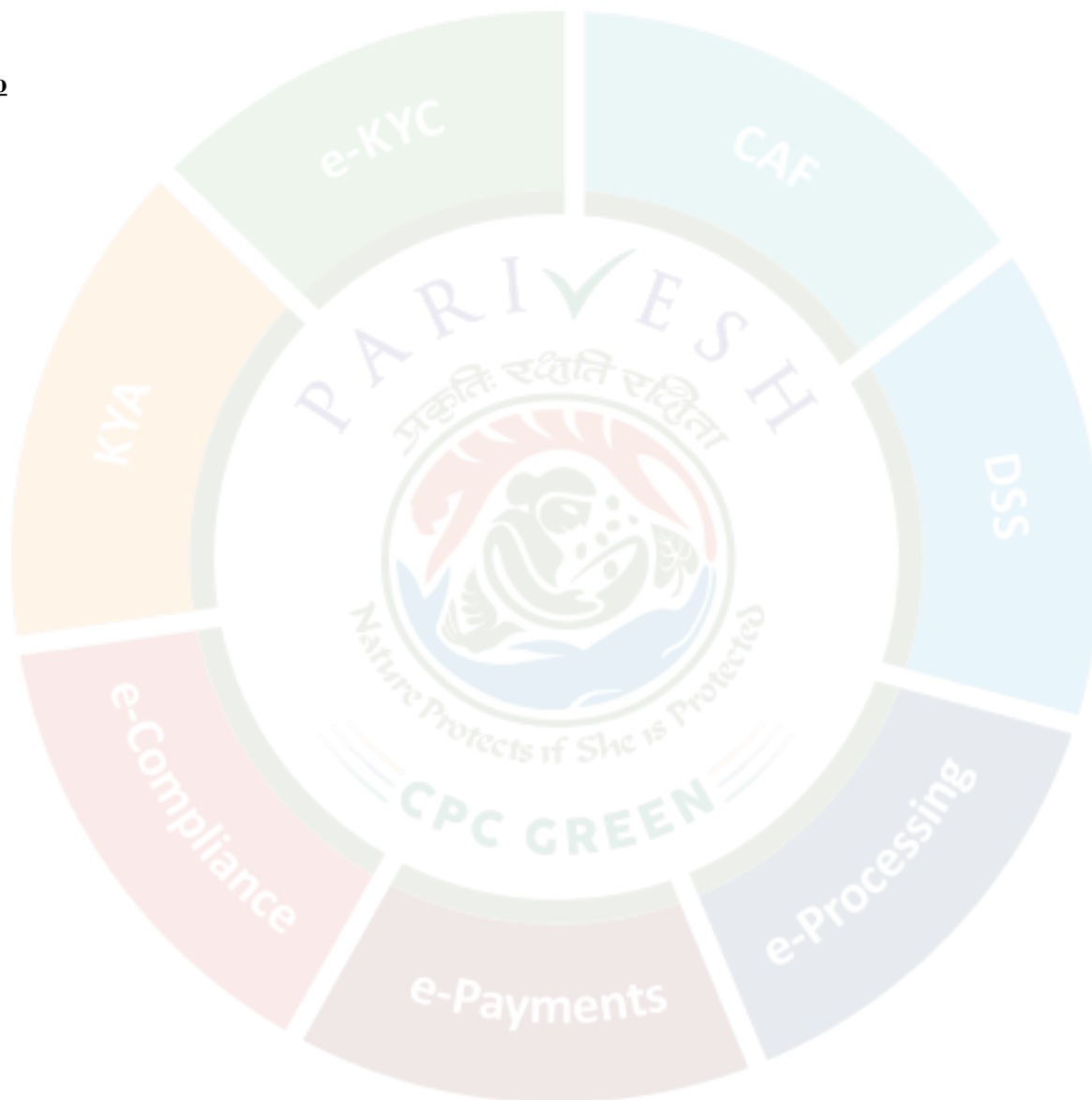
3. In view of the particulars given in the Para 1 above, the project proposal interalia including Form-7 were submitted to

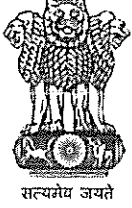
