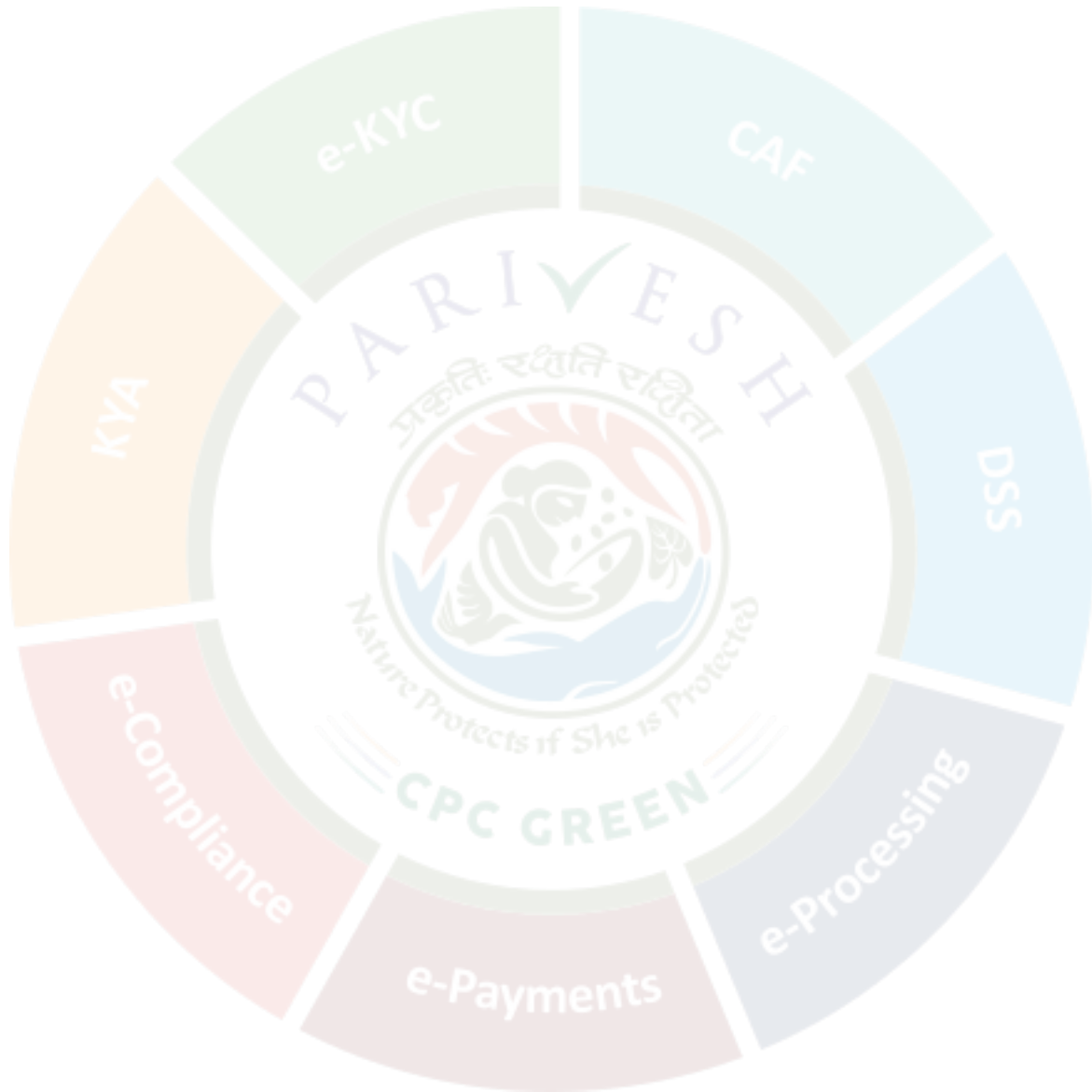

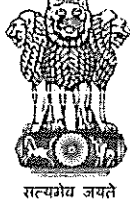

This is in continuation of Environmental Clearance issued by the State Level Environment Impact Assessment Authority (SEIAA), Jharkhand vide letter no. : EC/SEIAA/2024-25/3602/2024/44, Ranchi, Date : 16.04.2025 and further reference to your online application dated : 17.05.2025 and online application no : SIA/JH/MIN/537010/2025 requesting for corrigendum in Environmental Clearance with regard to correction in Production capacity as 74904.26 cum/annum or 2,02241.52 TPA in place of Proposed Capacity- 14994.99 cum/annum or 40, 486.47 TPA.

2. The State Level Environment Impact Assessment Authority (SEIAA), Jharkhand has accorded the Environmental Clearance vide office letter no. : EC/SEIAA/2024-25/3602/2024/44, Ranchi, Date : 16.04.2025 for "Churchu Stone Mine - I of M/s Ganesh Stone Works (Partners : Shri Suresh Kumar & Shri Vikash Kumar), Mouza : Churchu, Thana no. : 166, Anchal : Sadar, Distt. : Hazaribag, Jharkhand (1.214 Ha)". The project proponent has requested to issue the corrigendum in Environmental Clearance w.r.t. correction in Production capacity as 74904.26 cum/annum or 2,02241.52 TPA in place of Proposed Capacity- 14994.99 cum/annum or 40, 486.47 TPA.

3. Your request has been examined by the State Level Expert Appraisal Committee (SEAC), Jharkhand in its 124<sup>th</sup> meeting held on 23<sup>rd</sup>, 24<sup>th</sup>, 25<sup>th</sup>, 26<sup>th</sup> and 27<sup>th</sup> June, 2025, based on the information furnished/provided and discussion held, the State Level Expert Appraisal Committee, (SEAC) recommended to issue corrigendum of earlier Environmental Clearance

issued vide letter no. : EC/SEIAA/2024-25/3602/2024/44, Ranchi, Date : 16.04.2025 as the following:-

*“The PA's vide online application no. SIA/JH/MIN/ 537010 /2025 has requested for necessary correction in EC issued vide letter no. EC/SEIAA/2024-25/3602 /2024/44, dated 16.04.2025. The PAs had erroneously mentioned the Proposed Production capacity as 74904.26 cum/annum or 2,02241.52 TPA in place of Proposed Capacity- 14994.99 cum/annum or 40, 486.47 TPA.*

*The SEAC considered the same and recommends for issuance of corrigendum EC with corrected details as stated above. Other terms & conditions mentioned in the previous EC letter no. EC/SEIAA/2024-25/3602 /2024/44, dated 16.04.2025 shall remain the same”.*

4. The recommendation of SEAC, Jharkhand in this regard has been examined by the State Level Environment Impact Assessment Authority, Jharkhand in its 124<sup>th</sup> meeting held on 15<sup>th</sup> & 16<sup>th</sup> July, 2025 and decided **corrigendum in Environmental Clearance** with regard to Production capacity as 74904.26 cum/annum or 2,02241.52 TPA in place of Proposed Capacity- 14994.99 cum/annum or 40, 486.47 TPA to the said project proposal as recommended by SEAC above alongwith all other terms and conditions of earlier EC letter no. EC/SEIAA/2024-25/3602/2024/44, Ranchi, Date : 16.04.2025 shall remain the same.
